SUBJECT: \$75 HOUSING FEE EFFECTIVE JANUARY 1, 2018

The California Legislature passed and the Governor signed Government Code section 27388.1 mandates that effective January 1, 2018, a \$75 Housing Fee will be charged on certain recorded documents. The full text of Government Code § 27388.1 is provided at the end of this memo along with a schedule of recording fees. County Recorders must enforce the Housing Fee. The Housing Fee will be paid at the time of recording every real estate instrument, paper, or notice required or permitted by law to be recorded, except those expressly exempted from payment of recording fees, per each single transaction per parcel of real property. This fee is not to exceed \$225 per single transaction.

In order to carry out the implementation required by GC 27388.1, the Recorder's Office has developed the following guidelines for recording documents and the application of the \$75 fee:

Each document title presented shall be assessed the \$75 fee unless specifically exempted. Each single transaction involving (documents recorded "in connection with" with the same party(s) and property(s)) can only be assessed a maximum of \$225. There is no cap on transactions involving unrelated documents.

The Recorder's Office will review and apply exemptions specified in GC 27388.1. Exemptions are as follows:

1. All documents that currently record at no fee.
2. Any document where a documentary transfer tax as defined in Revenue and Taxation Code section 11911 is paid. Documents recorded "in connection with" the same transaction will also be exempt from paying the \$75 fee.
3. Documents transferring real property that is a residential dwelling to an owner-occupier. Documents recorded "in connection with" the same transaction will also be exempt from paying the \$75 fee. A Preliminary Change of Ownership Report (BOE 502-A form) may be used to support the owner occupied status. The form is available online at www.boe.ca.gov/proptaxes/pdf/sample_boe502a_rev13.pdf or your local County Assessor's Office.

The following is a list of documents explicitly set out in GC 27388.1 that will require payment of the \$75 fee (Important note: the code states that these documents are included, but the collection of the fee is “not limited to” these titles).

Government Code Section 27388.1.

(a) (1) Commencing January 1, 2018, and except as provided in paragraph (2), in addition to any other recording fees specified in this code, a fee of seventy-five dollars (\$75) shall be paid at the time of recording of every real estate instrument, paper, or notice required or permitted by law to be recorded, except those expressly exempted from payment of recording fees, per each single transaction per parcel of real property. The fee imposed by this section shall not exceed two hundred twenty-five dollars (\$225). “Real estate instrument, paper, or notice” means a document relating to real property, including, but not limited to, the following: deed, grant deed, trustee’s deed, deed of trust, reconveyance, quit claim deed, fictitious deed of trust, assignment of deed of trust, request for notice of default, abstract of judgment, subordination agreement, declaration of homestead, abandonment of homestead, notice of default, release or discharge, easement, notice of trustee sale, notice of completion, UCC financing statement, mechanic’s lien, maps, and covenants, conditions, and restrictions.

(2) The fee described in paragraph (1) shall not be imposed on any real estate instrument, paper, or notice recorded in connection with a transfer subject to the imposition of a documentary transfer tax as defined in Section 11911 of the Revenue and Taxation Code or on any real estate instrument, paper, or notice recorded in connection with a transfer of real property that is a residential dwelling to an owner-occupier.

(b) The county recorder shall remit quarterly, on or before the last day of the month next succeeding each calendar quarterly period, the fees, after deduction of any actual and necessary administrative costs incurred by the county recorder in carrying out this section, to the Controller for deposit in the Building Homes and Jobs Trust Fund established by Section 50470 of the Health and Safety Code, to be expended for the purposes set forth in that section. In addition, the county shall pay to the Controller interest, at the legal rate, on any funds not paid to the Controller before the last day of the month next succeeding each quarterly period.
