- **1:00-1:10pm (Introductions & Ice Breaker)**
 - a. Members of the meeting introduced themselves, the agency they are representing, and a fun fact about themselves.
- **1:10-1:25pm (CCOE Presentation)**
 - a. Irma Roque from CCOE provided an educational presentation about the effectiveness of the Head Start and State Preschool Health Program.
 - i. They were able serve 192 students between 0-5 years of age.
 - ii. CCOE provided meals for students
 - a. 18 meal accommodations
 - iii. 1 child needed emergency dental procedure
 - iv. 2 referrals were sent for those who had difficulties hearing
 - v. 5 referrals were sent for those who had vision issues
 - vi. Will include the brochure with meeting minutes
 - vii. CCOE is hosting Family Fair on April 15th

- **1:25-1:45pm (School Vaccinations Presentation)**
 - a. Heather from Colusa County Public Health provided a presentation on the importance of vaccinations
 - i. Discussed about heard immunity and how it is important for individuals to be vaccinated
 - ii. Heather explains about how vaccines can help for children from birth to age 6 from preventable diseases.
 - a. Explained the types of vaccines needed for certain age groups
 - iii. Lack of access to vaccines can negatively impact communities and how important it is to get vaccinated to prevent infecting vulnerable populations

- a. Heather provided examples of preventable diseases, such as chicken pox, polio, and diphtheria
 - b. Provided a breakdown of which vaccines are mandatory for students to get in order to join public school
 - iv. Promoted the multiple vaccine clinics that Colusa County Public Health is hosting

- **1:45-2:05pm (Focus Group/Group Discussion)**
 - a. Tobacco Education
 - i. **TUPE**- Big tobacco prevention conference in Stanford, through Stanford tool kit. Vape webinar that will be happening over zoom. Trying to get into swat, going out to each school to talk about BRIEF. Swat is students working against tobacco, trying to come up with draft email to send out so there can be some presentations done with the 5th graders. Trying to find age appropriate information on edible marijuana, maybe some sort of poison campaign. Maxwell Rodeo (May 20th)
 - ii. **ALA**- Some presentation planned for behavioral health here in Colusa. Trying to get foot in the door so they can talk to council members. Spotlight on smoke free events from American Lung Association.
 - iii. **Community health worker**- Medical program that gives wrap around services. Once they get that program going they will be doing outreach in the community.
 - iv. **Colusa County Tobacco Education Program**- Letter to the editor training. A training with the youth to speak up when it comes to tobacco policy. Planning to create an event for World No Tobacco Day on May 27th
 - b. Family Strengthening
 - i. Discussed vaccine exemptions. CA requires all vax exemptions to be entered into the website (provided by Heather in the presentation). Schools can log in and verify vax exemption and parents can submit an exemption request on the website. If the exception is not filed, then it is not valid.
 - ii. CPR classes are currently being offered by Maxwell Fire Dept. Parents can contact Kenny to schedule an appt. Hopefully the CHVP program will provide classes for parents in the future.
 - iii. Discussed the Bumps and Beyond Coffee Talks – Upcoming in Williams March 24th. Colusa – TBD.
 - iv. MCAH Car seat training coming in June. Training will be for Public Health staff first. Depending on space (Capacity is 20 people), training may be

open for CPS, First 5, Fire Dept. and other stakeholders. Dates and who can enroll: TBD.

- v. Currently, PH provides the car seats but parents have to go through First 5 for the car seat class.
- vi. Moderna Monovalent Primary Series is no longer being offered, and we will be running out of pediatric Moderna monovalent soon. Pfizer primary series is still available.

- i. Due to having new members in subcommittee, members introduced themselves and discuss what they are currently working on with their scope of work

d. Oral Health

- i. **Colusa County Oral Health**- Discussed prevention and access to care issues within Colusa County regarding oral health. Identified facilitator and barriers to care. Concluded on how to address barriers to care activities, such as Parent Café. Also to informing low income head start parents that CCOE can provide help with the costs of dental care need, gas cards for the dental visits and information about Colusa Indian Health's whereabouts and its extended office hours.
