 - a. Staff Report: Mary Fahey presented the following information:
Water Users Group
The Water Users Group met August 25, 2015. General discussion was held regarding: August DWR groundwater measurements, NASA's subsidence report, and the County's temporary moratorium on well permits. Their next meeting will be in November, exact date has not been scheduled.
Technical Support Team
Staff, along with the Ag Commissioner and TST members, has worked with Grant David's Engineering, Inc. on a scope of work to complete a county-wide study of groundwater conditions. The SOW will go to the Board of Supervisors for approval at their September 8

meeting. The work will include an assessment to describe the hydrogeologic and hydrologic characteristics and historical groundwater conditions in the Colusa County portion of the Colusa Sub-basin. In addition, a more detailed study will be completed in the area of the county that is demonstrating overdraft.

GIS software has been installed and staff is able to work on mapping projects. Staff has begun mapping all wells in the county, broken out in five year increments so we will be able to clearly see county-wide well development from 1970 to present. This is going to be a long-term, extremely time consuming project. We will have part time help from Department of Agriculture staff beginning in early September.

Darrin Williams: will TST be surveying landowners to obtain information.

Ms. Fahey answers that they are using Well Completion Reports for initial mapping. They will be trying to map every well in the county. However not everyone has turned in well completion reports.

Roy Hull: Our well completion reports date back to 1920.

TST is beginning in 1970 because the reports are a little easier to interpret and many of the older wells do not exist today.

SGMA Update

Suggestion from Lorraine Marsh on how to improve hydrographs, asked Roy Hull to bring in the next presentation ways that land owners can contribute their information to be included.

Brief discussion on real time monitoring in season for groundwater wells because of all the activity going on between spring and fall to get an idea of how the water recharges at different times of the years.

Next Roy Hull visits request from Lorraine Marsh to provide a more detailed presentation. Lorraine would like to put together the questions we have so that DWR will know what information to provide.

b. Discussion – NASA Subsidence Report - Roy Hull, DWR

Roy Hull provided a Power Point Presentation on Subsidence in the Upper Sacramento River Valley

Roy Hull notes that the key points to look at in the measurements are the trending changes. There was a discussion held on getting a more detailed map of the Arbuckle area where land subsidence is detected by NASA.

c. Discussion/Report – Colusa County Urgency Ordinance; Outstanding well permits

Suggestion on having meetings sooner than once every quarter.

Mary Fahey reports: June 30th the County place a moratorium on well permits, put into place as a protective measure.

Brief discussion was held on amendments to the ordinance due to water running dry in some residential wells, those wells needed to be drilled deeper or a new well put in.

Mary Fahey mentioned the study with Grant Davids. The area south of Hahn Rd, where he will do a more detailed water balance. We should have a lot of good information from that report that will help the board of supervisors in determining where to go from there. All information will be put into the GSP.

Mary Fahey reports that she took last year's goals and objectives to start with.

STAFF REPORT
Water Users Group

The November Water Users Group meeting was cancelled. Planned discussion items will be covered at the December Commission meeting. WUG members have been encouraged to attend the Commission meeting. The WUG will reconvene in 2016.

Technical Support Team

The TST continues to work on the groundwater level monitoring network, analyzing groundwater conditions, and mapping of wells. Roy Hull, DWR Northern District, will present a Groundwater Update at today's meeting.

Prop 1 Funding Application:

An application for Prop 1 funding has been submitted to DWR for technical consultant work. The project includes

- Characterize existing and possible future groundwater development County-wide
- Develop County-Wide Groundwater Level Monitoring Well Network
- Develop a Groundwater Data Management Program

If funded, this project will greatly accelerate the TST efforts and help the County and local agencies in their efforts to determine a local governance structure (GSAs) and development of GSPs.

Temporary Urgency Ordinance

Dauids Engineering continues work on a county-wide groundwater assessment that will supplement local knowledge of groundwater conditions, and help inform the BOS as to how to move forward when the Urgency Ordinance expires on January 31, 2016. The study will also be a valuable asset for SGMA implementation. Grant Davids will present findings to the BOS at their January 12, 2016 meeting.
